Document No. II Rules and Regulations

1. Name of the Organisation M.B.R. Educational Society
2. Head Office and Address for Correspondence 5-9-22/31, Adarshnagar, Hyderabad - 500063.
3. a. Membership Life Membership - Rs. 100
General Membership - Rs. 50
Admission Fee - Rs. 40
- b. Category of Members Monthly / Annual / Life
- c. Admission Fee and the annual subscription or monthly subscription Life 100/-, General 50/- & Month 10/-
- d. Cessation of Membership The Membership shall be forfeited if the subscription for the year is not paid by 30th September of the year to which it relates and the member there upon shall cease to have any rights and privileges.
- e. Re-admission Readmission to membership shall be made by the Executive Committee in application either by releasing the dues or as a new member.
4. General body:-
 - i. The total membership of the Society shall constitute its General Body.
 - ii. Meetings of the General body shall take place as follows:
 - a. The Executive Committee shall arrange a general body meeting atleast once in a year by giving a notice with agenda of not less than a fortnight.
 - b. The quorum for the general body meeting shall be 35% of the total membership. In case a meeting of the general body can not take place for want of a quorum and if the decision of the general body is urgently required on any issue, reference may be made to the general body by postal ballot.
 - c. Agenda for the general body meeting shall include
 1. Approval of expenditure and auditors' report for the relevant year.
 2. Approval of the report of the activities of the society.
 3. Election of the Executive Committee etc.,
 4. Appointment of the Auditors.

- i) Executive Committee shall consist of Five members and out of them the following office bearers shall be elected by the EC viz., President, Vice President, General Secretary, Joint Secretary and Treasurer.
 - ii) The Members of the Executive Committee (Governing Body) shall be duty bound to attest the signatures of all the members of newly elected Executive Committee and to see that the said signatures of the out-going Governing body tally with the annual list as filed with the Registrar of Societies before 15 days of the succeeding month of the month in which elections were held.

Functions of the Executive Committee and Office Bearers:

1. **President:** He/ She presides over all the meetings of the General body and Executive members. He can cast his vote in the case of a tie in decision-making. He can supervise all branches of the Society.
2. **Vice President:** He/ She shall assist the President in discharging his functions. In the absence of the President, he will perform the duty of the President as entrusted by the President.
3. **Secretary:** He/ She is the Chief Executive Officer of the Society and Custodian of all records relating to the Society and correspondent on behalf of the Society. He has to take on record all minutes of the Society. He would convene both the Executive Committee and General body of the Society with the permission of the President. He guides the Treasurer in preparing the budget and expenditure statement to place before the General body for its approval.
4. **Joint Secretary:** He/ She has to do the work entrusted by the Executive Committee. He has to assist the Secretary in discharging his duties. In the absence of the Secretary, he can perform the duties of the Secretary.
5. **Treasurer:** The Treasurer shall be responsible for the general conduct of finance of the Society. The Treasurer shall receive all the funds of the Society and deposit the same to the account of the Society. He shall also draw money from the account, if necessary. He shall maintain proper account of all the receipts and payments and report to the Executive Committee as and when called to do so by the Executive Committee. He shall arrange for the accounts to be audited prior to its submission to the Executive Committee meeting.
6. **Office Bearers:** They are the persons responsible to attend to such activities of the Society which the Executive Committee entrusts them.
7. **Quorum:** Half of the total members for General body meeting and $\frac{1}{4}$ for Executive Committee meeting.
8. **Funds:** The Society shall raise funds for pursuing its objectives through:
 - a. Subscriptions from the members
 - b. Sale of publications
 - c. Grants-in-aid from Government and other Organisation members
 - d. Term loans from banks and /or other financial institutions for expansion of the activities, purchase of vehicles for the Society and for any other purpose that is required for the proper functioning of the society.
 - e. Any other source approved by the Executive Committee

9. No amendment or alterations will be made in the rules and regulations of the Society without the prior permission of the Director of Income Tax - Exemptions, Hyderabad, Andhra Pradesh.
10. In the case of dissolution, the properties of the Trust shall be transferred to a Society or Trust having similar objects and which is registered under Section 12A & 80G of the Income Tax Act, 1961.
11. The Office bearers being the persons referred to in Section 13(1)(d) of the Income Tax Act, 1961 should not benefit either directly or indirectly out of Income or Property of the above mentioned Trust from the date of assuming office.
12. The funds of the Society shall be invested in securities specified under section 11(5) of the Income Tax Act, 1961.
13. The Society shall maintain books of account, which shall be closed every year on 31st March and the funds of the Society shall be audited by a Chartered Accountant.
14. The Society is irrevocable.
15. The properties and income of the Society shall be utilized exclusively for the purpose of promoting and pursuing the objects of the Society and no portion of it will be used for the payments of the members and office bearers of the Society.
16. The activities of the Society shall be carried out only in the geographical territory of India and no activities shall be extended and carried out anywhere outside India.
17. The Society shall not carry on any activities with the object of earning profit.
